### Latin London: the Lives of Latin American Migrants in the Capital

This book examines the lives of Latin American migrants living in London. As a largely invisible population, the volume addresses the growing importance of Latin American migrants in the capital, focusing on the experiences of 'ordinary' Latin Americans and how they carve out a life for themselves in one of the most expensive cities in the world. In uncovering this largely neglected world, *Latin London* draws on a unique body of interview material, mainly with Colombian, Ecuadorian and Bolivian migrants, but also with other nationalities, and highlights both the hardships and successes among these migrants. It illustrates how they survive economically, socially and culturally, outlining the role of employment, support networks, the church and migrant organisations, as well as the nature of their transnational connections. Conceptually, the book engages with debates about integration, coping and transnationalism.

### The Contemporary Canadian Metropolis

Building on a conference on 'The Canadian Metropolis' at the Institute for the Study of the Americas and the Canadian High Commission in February 2007, this series of essays combines social science, architectural and cultural studies perspectives on the analysis of contemporary change in major Canadian cities, exploring the connections and the tensions between diversity, multiculturalism and cosmopolitanism on the one hand and economic change, creativity and urban regeneration on the other.

# Contesting Clio's Craft: New Directions and Debates in Canadian History

This book highlights the work of nine early career scholars who offer innovative thoughts on present and future approaches to the study of the Canadian past. Moving beyond the debates over political vs social history that have dominated the field since the 1970s, the essays in this collection suggest novel questions and approaches while delving into recently overlooked subjects. There is a particular emphasis here on international, transnational and comparative approaches to the past. Essays cover such topics as the Atlantic World, oral history, postcolonialism, public history, historical periodisation, Canada's place in the British Empire, French-English relations, as well as the art of history as a discipline and practice. A "must read" for Canadian historians, the book will also appeal to international scholars interested in these issues and curious about the contribution that Canadian history can make to the broader history of the Americas.


## America's Americans: Population Issues in U.S. Society and Politics

This book examines the social, cultural, economic and political effects of modern demographic change in the United States. The specialist contributors from the US and the UK draw on new research to analyse a wide range of issues pertaining to the diversity of American society. Among the subjects considered in this study are: Latino immigrant incorporation; racial and ethnic integration in metropolitan contexts; population and self-determination issues pertaining to Native Americans; public policy issues relating to immigration; the growth of the US prison

population; the changing nature of poverty in the US; the politics of demographic and social change at national and local levels; and the historical change in the labour force participation of women.

## Football in the Americas: Fútbol, Futebol, Soccer

Football (soccer) has a long history in the Americas, but currently displays many signs of crisis. In South America the combination of spectator violence, poor business management, and the emigration of players is undermining professional football. In the United States, in contrast, a professional league (Major League Soccer) has taken root in the last decade, and the US women's team has gained international success. Football has always provided its players and its fans with identity and belonging, whether to the nation or to a particular social

group. It has been both a vehicle for the politically ambitious and an arena in which citizens can make sense of national failings and contest existing power structures. This volume explores many of these themes. The fifteen essays range widely, with theoretical and empirical contributions on the region as whole, as well as chapters specifically on Argentina, Brazil, Peru, Mexico, and the United States.




# Bolivia: Revolution and the Power of History in the Present. Essays

This volume brings together essays written over three decades on Bolivian history and politics. Opening with a contemporary survey of the new government of the MAS headed by Evo Morales, the chapters here review the neo-liberal experiments of the 1980s and 1990s, the strategic and intellectual failures of Che Guevara's guerrilla *foco*, the origins of the Revolution of 1952, explanations for the dominance of the *caudillos* of the 19th century, and the extraordinary story of Francisco Burdett O'Connor, whose life

combined liberation struggles on both sides of the Atlantic.



### **American Civilization**

Charles A. Jones 2007, 978-1-900039-82-6 (pb.) £12, €20, \$20, 105 pages.

Far from being exceptional, the United States is the most American of nations, sharing with its neighbors to the south an aspiration to realize liberalism in a racialized society and distinguished from them chiefly by the greater material capabilities it has been able to apply to this historic task. Sometimes regarded as Western, the United States is separated from Western Europe by distinctive levels and styles of religiosity, public violence, respect for law and concern with materiality that, far from constituting a claim to exceptionality, bind it firmly to the rest of the hemisphere, from which it was separated only by the strange accident of historiography that created a separate 'Latin' America little more

than a century ago. This book looks forward to a truly American century.




## Mexican Soundings: Essays in Honour of David A. Brading

The essays in this volume convey the enduring nature of many of the questions raised by David Brading's work, and reflect the wide range of his interests: from Mexican Baroque and post-Tridentine Catholicism to studies of the dynamics of state building in nineteenth-century Mexico, and of the problem of Mexican national identity. The contributions represent a wide chronological spread from the late seventeenth century to the twentieth century, as well as geographical diversity (Mexico City, Querétaro and Puebla). Part I

comprises an autobiographical essay by David Brading, an appreciation of him by Enrique Florescano and an historiographical assessment of Brading's work by Eric Van Young. Part II gathers together six essays by former students (Susan Deans-Smith and Ellen Gunnarsdóttir) and colleagues (Brian Hamnett, Marta García Ugarte, Guy Thomson and Alan Knight).




# Democracy after Pinochet: Politics, Parties and Elections in Chile

### This book explores how democracy has developed in Chile since the end of the military dictatorship in 1990. It brings together an examination of international influences on Chilean political development with empirically-based analyses of Chilean political institutions and change. Chapters one and two examine international aspects of the 1973 coup and how these influenced the development of politics inside Chile. Chapters three, four and five provide empirical analyses of the 1989, 1993 and 1999/2000 presidential elections.

Chapter six investigates how the Pinochet factor influenced developments after 1990 and the Chilean reaction to Pinochet's arrest in London in 1998. Chapter seven assesses changes in the Chilean party system and links these to similar processes elsewhere. The final chapter examines the paradox that despite economic and social advances, opinion polls report a low level of attachment to democracy and very low levels of confidence in political institutions.



### The Struggle for an Enlightened Republic: Buenos Aires and Rivadavia

This book analyses the evolution of politics, ideas and culture in Buenos Aires in the years 1820-1827 – a period in which the United Provinces of the River Plate, what is now Argentina, were largely dominated by the political influence of Bernardino Rivadavia. The main focus of this work is centred on the effects of Rivadavia's enlightened reforms on Buenos Aires society during the years 1821-24, during his period as Minister of Government of the city, and the causes of his eventual political downfall in 1827 shortly after his election as first president of the reunified Argentine Republic.

George W. Bush is widely regarded as a president of transformative significance. This volume of essays analyses the ambitious but controversial agenda that he has pursued at home and abroad. The contributors assess Bush's presidency in terms of its historical context, first-term record and second-term prospects. They consider his administration from the perspective of its engagement in an ideologically-driven project to consolidate conservative ascendancy over US politics and public policy, and to promote America's interests

and values in the unipolar world of the early twenty-first century. They evaluate the elements of political change and continuity in George Bush's America. Some chapters focus on the extent to which the Bush agenda is new or a continuation of previous trends. Most contributors examine how far Bush has succeeded in overcoming political, institutional and international resistance to his conservative agenda and assess his prospects for further success.




## Francisco de Miranda: Exile and Enlightenment

## Making Institutions Work in Peru: Democracy, Development and Inequality since 1980

The elections of 2006 in Peru are an appropriate moment to reflect on Toledo's term as president and on the broader agenda for building a polity more democratic and inclusive. In a country of extreme social inequality, such an aspiration represents an enormous challenge. The sudden collapse of the Fujimori regime, which had dominated Peru for the entirety of the 1990s, provided an opportunity for institutional reform and

rebuilding. Toledo's election victory in 2001 seemed to provide this. The impetus proved shortlived, as the new president's popularity sank to unprecedented levels. The public support for Peru's democratic institutions continued to haemorrhage. This collection suggests that the challenges of institutional development run very deep, and are not peculiar to one government in particular. Institutional change in Peru is part of a much wider process of transformation.


Caciquismo – roughly, 'boss politics' – has played a major role in Mexican political and social life; and caciques of diverse character – political, syndical, agrarian, 'red', right-wing, and white-collar – have exercised great power within Mexico's distinctive political system. Indeed, the peculiarities of that system have depended on this kind of informal politics which combines repression, clientelism and charismatic authority. As such, caciquismo fits uncomfortably within the formal analysis of laws, parties and elections, and though its demise has often been predicted, it has survived, evolved and adjusted to Mexico's

rapid post-revolutionary transformation. Embodying the research of historians, political scientists, sociologists and anthropologists, this book reevaluates the crucial role of the cacique in modern Mexico, combining both case studies and more general comparison and theory; it suggests that, thanks to its Protean character, caciquismo has survived decades of change and upheaval and remains an important, if underestimated, feature of recent Mexican politics.




### Vargas and Brazil: New Perspectives

More than seventy-five years after Getúlio Vargas's 1930 "Revolution" and more than half a century after his suicide, politicians, scholars and the Brazilian public still debate whether his era has actually come to an end. Yet, as Brazil's leading news magazine Veja emphasized in August 2004, Vargas's enigma will not be deciphered through uncritical studies and hagiographic novels, but through serious scholarly analyses. Vargas and Brazil: New Perspectives unites scholars from Brazil, the US and Europe, who draw on a close re-reading of the literature, hitherto unavailable or unused sources, and a wide array of methodologies, to shed new light on the political changes and cultural representations of

Vargas's regimes, thereby exploring why he meant so many different things to different people.



### America and Enlightenment Constitutionalism

This book shows in detail the Enlightenment origin of the US Constitution and vividly analyses how the Enlightenment's basic ideas were reformulated in the context of America. It is particularly successful in bringing out the competing strains of Enlightenment thought and of articulating crucial Enlightenment concepts of public opinion, equality, public reason, the relationship between the legislature and the judiciary, revolution, law, and the people in their American context. The collection is timely given contemporary debates between conservatives and liberals about constitutional interpretation.

## No. 6 Nationalism Unbecoming: George W. Bush, War and the American Democratic Tradition

This paper examines the upsurge of nationalism in the Bush administration and seeks to understand it in relation to crucial events in the American past. Richard Crockatt argues that American nationalism is a compound of democratic ideology, stemming ultimately from the Revolution, and of the assertion of centralised power through military means, manifested most obviously in the Civil War. The Civil War and the period of Reconstruction which followed it cemented the notion that democracy could be imposed by force. Crockatt explores the idea that the dynamics of American foreign policy in the twentieth and twenty-first centuries owe much to the dynamics of national growth in the eighteenth and nineteenth centuries.



# No. 5 London and Latin America: 200 Years of Shared History

This lecture was delivered in the House of Commons to a general audience as the 2007 Simón Bolívar Lecture, organised by the Anglo-Venezuelan Society. The talk reflects on the two centuries that have passed since the cause of Latin American independence became a leading foreign policy issue in London. The relationship has included 'the best of times' and 'the worst of times', as has the

experience of those Latin Americans, distinguished and more modest folk, who have lived in London.



## No. 4 Americas Plural: Old Wine in New Bottles?

James Dunkerley

In this extended version of a lecture given in Toronto on diasporas and migration in the Americas, James Dunkerley reviews the academic debate over the study of the Americas – Anglo and Latin alike. Against the claims of "American Exceptionalism", many liberal scholars have promoted the idea of multiculturalism and an international dimension to American Studies, but some poststructuralist scholarship evades the challenges of a creative inter-

disciplinary approach. Through brief statistical and cultural portraits of the Hispanic population of the USA, Dunkerley suggests that neither "disciplinary heroism" nor a universal deconstructionism can by themselves provide an adequate account of the current Hispanic experience and its origins. Equally, all the signs of recent years are that the mere championing of the "American Creed" of the Founding Fathers is an exercise in anachronism unless accompanied by recognition of the rapidly evolving social fabric of the USA.



### No. 3 'Our people are paralyzed for want of leadership': Abraham Lincoln, Jefferson Davis and the American Civil War

Richard Carwardine, prize-winning Abraham Lincoln biographer, sheds light on Lincoln's Civil War leadership through comparing it with that of Confederate President Jefferson Davis. It has been commonly argued that Lincoln was a better war leader, but this

study breaks new ground in explaining what that superiority consisted of. The author also argues that Davis was in key ways himself an effective leader, and that if Lincoln's achievement overshadows his, then we should see this as a mark of the latter's qualities than of the deficiencies of the former.

## No.2 The Hispanic World in the Historical Imagination

### Fernando Cervantes

This lecture considers how Spain and the Hispanic world have been portrayed by European commentators (including the Spanish themselves), from the sixteenth-century to our own time. The notion that in relation to Europe the Hispanic World is somehow different is shown to have been extraordinarily resilient. Since 1989 the conventional interpretations that conceived of the modern system of sovereign nation-states as the

culmination of an inevitable advance in European history have been progressively questioned. It seems timely to attempt a reassessment of the Hapsburg efforts to organise a supranational system in the early modern period, and by extension to attempt a revision of the recurring view of Spain and its world as somehow extraneous or peripheral to European history.



# No.1 Mexican Foreign Policy at the Turn of the Century: How Domestic a Foreign Policy?

This study considers the manner in which the process that culminated in the signature of the North American Free Trade Agreement (NAFTA) prompted a discussion about the 'new orientation' of Mexico's foreign policy. This was part of a broader debate about transformations in the international system, especially with the end of the Cold War, and also

regarding changes within Mexico. The task of understanding the new direction of foreign policy was facilitated by the election of Vicente Fox in 2002, when the official discourse adopted the idea of a new foreign policy, defined as active, and gave it a predominant place in the government's priorities. The foreign policy project identified 'strategic' objectives, such as the promotion of democracy and the protection of human rights at the international level, and the development of a long-term view of a North American region. This new policy is assessed in the context of Mexico's previous foreign policy.
